Official Minutes of the Pierz City Council
November 27, 2017

The City Council meeting was called to order at 7:00 p.m. at Pierz City Hall by Mayor Toby Egan.

APPROVAL OF COUNCIL MINUTES:

A motion was made by Council Member Stephanie Fyten and seconded by City Clerk Dave Fischer to accept the minutes from the November 13, 2017 City Council Public Hearing meeting. Motion carried unanimously.

A motion was made by Council Member Kyle Bednar and seconded by Council Member Mike Menden to accept the minutes from the November 13, 2017 Regular City Council meeting. Motion carried unanimously.

PIERZ FIRE DEPARTMENT:

Preimesberger stated the Fire Departments portion of the shed would be paid out of the pull tab money, but would not be able to pay for the Public Works portion.


Smude plans to bring forward the sidewalk policy updates and right of way ordinance amendments at an upcoming meeting in December.
