November 28, 2016

APPROVAL OF COUNCIL MINUTES: A motion was made by Council Member Mike Menden and seconded by City Clerk Mary Korf to accept the minutes from the November 14, 2016 Public Hearing Meeting. Motion carried unanimously.


Nicole Nordlund, City Administrator reminded Council Members and Committee Members to turn in their hours from their extra meetings.
