ANNEXATIONS

1601.01. Intent. This Ordinance so approves and acknowledges the Annexations herein:

1601.02. Annexation of 1956. Annexing the north half of the southwest quarter (N 1/2 of SW 1/4) of Section 9, Township Forty, Range 30, Morrison County, Minnesota, to the Village of Pierz. The above described real estate is hereby annexed to the Village of Pierz and declared to be a part of said village and within the jurisdiction thereof.

1601.03. Annexation of 1982. Annexing the part of the SW ¼ of the SE ¼ of Section 8, Township 40, Range 30, Morrison County, Minnesota, described as follows: Commencing at the SW Corner of said SW ¼ of SE ¼, thence North 00 degrees 00 minutes 08 seconds East, assumed bearing, 1327.9 feet along the West line of said SW ¼ of SE ¼ to the NW corner thereof, thence North 87 degrees 49 minutes 39 seconds East 539 feet along the North line of said SW ¼ of SE ¼, said line also being the South line of a public roadway to the point of beginning of the tract to be described; thence continuing North 87 degrees 49 minutes 39 seconds East 200 feet along said North line of the SW ¼ of SE ¼, thence South 00 degrees 00 minutes 08 seconds West 150 feet, thence South 87 degrees 49 minutes 39 seconds West 150 feet, thence South 87 degrees 49 minutes 39 seconds West 200 feet, thence North 00 degrees 00 minutes 08 seconds East 150 feet to the point of the beginning. The above described real estate is hereby annexed to the City of Pierz and declared to be a part of said village and within the jurisdiction thereof.

1601.04. Annexation of 1988. The corporate limits of the City of Pierz are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectively as if it had originally been a part thereof: A Point 37 links South and 50 links West of the Northeast Corner of Southeast Quarter of Southwest Quarter (SE 1/4 SW 1/4), Section Eight (8), Township Forty (40), Range Thirty (30), thence West 500 links, thence South 100 links thence East 500 links, thence North 100 links to Point of Beginning, excepting there from the South 15 feet thereof. Said area comprising 2 acre. The above described real estate is hereby annexed to the City of Pierz and declared to be a part of said village and within the jurisdiction thereof.

1601.05. Annexation of 1988 Part 2. The corporate limits of the City of Pierz are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectively as if it had originally been a part thereof:

That part of the East Half of the Southeast Quarter of Section 8, Township 40, Range 30, Morrison County, Minnesota, described as follows: Commencing at the Northeast corner of said Northeast quarter of the Southeast Quarter; thence South 00 degrees 00 minutes 00 seconds West, assumed bearing, a distance of 1266.04 feet along the east line of said East Half of the Southeast Quarter to the point of beginning of the tract to be described; thence continuing South 00 degrees 00 minutes 00 seconds West a distance of 120.00 feet along said East line; thence North 90 degrees 00 minutes 00 seconds West a distance of 183.00 feet; thence North 00 degrees 00 minutes 00 seconds East a distance of 120.00 feet; thence South 90 degrees 00 minutes 00 seconds East a distance of 183 feet to the point of beginning. Said tract contains 0.50 acres, more or less. Subject to a public roadway easement across the easterly portion thereof. Said area comprising 2 acre. The above described real estate is hereby annexed to the City of Pierz and declared to be a part of said village and within the jurisdiction thereof.

1601.06. Annexation of 1988 Part 3. The corporate limits of the City of Pierz are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectively as if it had originally been a part thereof: The South 15 feet of that tract of land described as follows, to-wit: Commencing at a point 37 links South and 50 links West of the Northeast corner of the Southeast Quarter of the Southwest Quarter (SE 1/4 SW 1/4), Section Eight (8), Township Forty (40), Range Thirty (30), thence West 500 links, thence South 100 links; thence East 500 links; thence North 100 links to the point of commencement. Said area comprising 0.11 acre. The above described real estate is hereby annexed to the City of Pierz and declared to be a part of said village and within the jurisdiction thereof.
